# **Update on Township Hall**

The Portland Township Board continues to move forward with plans for the new Township Hall, but in cautious and careful ways. Money that was received from the Federal Government in 2021 as part of the American Recovery Plan Act (ARPA) will be used this summer to construct the driveway, parking area, and recycling area. This entrance will be located on the southernmost edge of the property, off Knox Road.

The Spicer Group is in the process of drawing up detailed plans for the new building. An application is being prepared to apply for a mortgage through the USDA Rural Development Community Fund program.

# Reminder About Burning Permits

A reminder to all Portland Township residents, that you must have a burning permit for ALL open burning. The application for the permit can be found on the Portland Area Fire Authority website: https://www.portlandfiremi.com/.

This form will need to be completed each year and is valid until December 31. You may not burn without a permit!

After obtaining your permitn you will still need to call 517-647-4111 prior to burning to be sure that there are no burning bans in effect. You are responsible for any and all damage caused by your burning even with a permit. You may also be charged with fines and/or cost of services for failure to comply with all State, City, and Township laws and ordinances.

The PAFA website also contains information on what can and cannot be burned, etc.

# PAFA to Order New Pumper Truck

Portland Township along with Danby Township and the City of Portland make up the Portland Area Fire Authority (PAFA). PAFA oversees the budget and planning for the fire department, and has been very proactive at anticipating vehicle and equipment replacements. As part of their long-term plan, they will soon be ordering a new pumper truck to replace the current truck that was manufactured in 1991.

This will be the third new truck purchased since 2015 and should be the last large truck that will be needed for the foreseeable future. There are plans to replace some smaller brush trucks plus continue contributing to a vehicle replacement fund to reduce future interest expense.

# **New Drop Box for Tax Payments**

The drop box for your property taxes has moved to 773 E Grand River Avenue, in the front of the Emergency Services Building. There is now one central drop box for all election and tax material. There is not a drop box at the Treasurer's home.

#### Postmark Does Not Prevent Interest/Fees

You can still mail your taxes to Clerk Michelle Schneider, 9770 Marsalle Road, but please note that payments made by mail often are late to arrive. By law, postmark dates do not count. **Your payment MUST BE RECEIVED by the due date.** If your payment is received after the due date, interest and fees will be applied. Please allow two weeks for delivery to prevent interest and fees,

or mail your payment via certified

mail.
